# The flight of the Honey bee

Passengers on an internal flight in Russia got an unpleasant surprise when two hives of bees smuggled onto the plane escaped - mid-air. The bees - which were carried on in cardboard boxes are thought to have become agitated in the pressurised cabin on the 10-hour Yakutia Airline flight to Moscow from Blagoveshchensk, and Quick-thinking air managed to break free. hostesses on the flight managed to round the bees up in a wardrobe in Business class by sealing it with sticky tape.

Unfortunately, when the plane then arrived at its' next destination, Barcelona, the new discovered there were still several bees on board.

Now Yakutia Airlines could be 'stung' with a massive £100,000 bill for fumigation of the Boeing 757, and compensation for delays caused to the forwarding destination, Spain. trafficker has since made a claim that an airport official at Blagoveshchensk asked him to carry the boxes to Moscow, where he would then be met at the airport. This has reignited issues surrounding the integrity of russian internal flight airport officials, who are historically known for being rather lax when vetting on-board luggage

#### **GM Honey**

A recent ruling by the European Court of Justice could have wide ranging implications for the Food Industry and in particular Beekeepers.

On the 6<sup>th</sup> September the European Court of Justice reached a decision on a dispute raised by Karl Henz Bablok a German Beekeeper against Monsanto Technology LLC. The dispute was raised concerning the presence of trace amounts of genetically modified organisms in his honey, namely pollen from a local field of GM maize. The ground-breaking ruling was that contaminated by pollen from a GM maize variety (MON810) cannot be sold. If Karl Bablok had sold or even given away his honey for free, this would have been an offence against the law and could have resulted in charges being brought against him.

MEP Bart Staes stated that:

"Beekeepers in the EU need their honey to be of as high quality as possible, so they have an economic that GMOs interest and other kinds contamination do not end up as traces in their honey. Today's outcome could have far-reaching implications for the honey market, with EU countries importing honey from GM producing countries and two of the main EU honey-producing member states (Spain and Romania) having the production of authorised this maize. Clearly, EU beekeepers should not be held responsible for the negative implications of the contamination of their honey."

The original dispute concerned GM maize variety (MON810) but the ruling affects all GM crops and means that honey which contains trace amounts of pollen from any GM crop must be labelled as such and undergo full safety authorisation before it can be sold as food. The problem in the UK is that due to campaigns against the growing of GM crops the location of these crops is closely guarded and as such it may be impossible to know if our honey may contain any pollen from GM crops, a problem we are unlikely to experience in Cumbria where the growing of crops is limited. The ruling opens the way for beekeepers to claim compensation from the producers of GM crops for the loss of revenue from sales of honey and other apiary products.

The judgment could cause many imported honeys and other food stuffs to disappear from the shelves in European supermarkets. Whether this is just the start which could result in all honey containing pollen from any GM crop becoming unsalable or just another kink in the road for the long running saga of GM food is yet to be seen.
